1.	Acknowledgement of Country was given by Rosie E. Her message was how an acknowledgement was similar,			
	to saying grace at meal times. Why we do it is just the same as thanking the farmers and growers of our food			
	before eating. She spoke of inherited land and knowledge from different peoples and tribes such as the			
	Butchulla and Kabi Kabi. We inherited this land and lake areas from the early peoples and we remember			
	elders of past and present. We remember their looking after the land here and we acknowledge them being			
	here.			
	Rosie was thanked by the president, Rob D.			
2.	Rob D gave a Welcome to all for coming along and reminded all, of the exits and facilities, as well as			
	emergency information.			
3.	Paul Armstrong (in the capacity of Commodore of LCSC) had accepted our invitation to inform the meeting			
	about LCSC matters relevant to the community. Rob D introduced him.			
	Paul wanted to give a background first, of club activities. The Club has run events for many years and always			
	got licences for liquor. The Council spoke with the club committee about event licences and holding events			
	which means permits. The sailing club felt they (the Council) didn't understand what happens here at Lake			
	Cootharaba and how our regattas are run. An example was the road closure during the Christmas period for			
	a National regatta, and it was not done as well as the council had expected. The Nationals usually came			
	around at the Christmas period and the council said it wanted event permits for all, of the regattas.			
	The club officials felt that as our events start and finish on the water then the council doesn't have the			
	jurisdiction over these, on water events.

	The directives and things the shire council are wanting, are hard to do, as the club members cannot deal with				
	parking and who goes where, when events are on, as the club feels council should be doing or helping with				
	this. The club does it's best to inform competitors about leaving trailers and using public spaces. The club				
	does try to consider the community and knows what the disruption, using the main beach can be to the				
	community.				
	A Council Sports Liaison Officer wanted to see what we do here and visited. She didn't realise how many				
	people come to Noosa Shire to sail here and what they need and what facilities are here. The Officer didn't				
	know the sailing club was owned by members and not just been given shire land for a club house. As with				
	present day events, permits are still wanted by council. She is going to be talked to again. The club is				
	participating in grants and programs to improve facilities which will help us to hold better events.				
	When speaking with the council it was put to them about the Olympic events and if a dinghy event may be				
	held here. She took that on board and went back to see, however it was said that all the Olympic sailing				
	event venues have been decided already.				
	Paul had sent out an email to members and mentioned about having an Olympic event and then get some				
	grant money, but there was a lot of negative replies and as it turns out event permits need to be applied for.				
	As far as the club was concerned, they thought it not a community priority and not needed to be discussed				
	with them first. He stated he felt that previous council members did not want to get involved with the				
	Olympics but it may appear that present councils are more concerned to be involved with Olympics.				
	He hasn't heard back from the contact, from the last email. She was helping with giving aid to applying for				
	and writing applications. He apologised if he (sailing club) has been seen to do the wrong thing. He has said				
	that he will try to let community know earlier in future but some things are only affecting the sailing club and				
	the club will continue to be open and continue to be transparent with our community. Things can be				
	circulated through the secretary in inform groups such as the CCA.				
	Trevor Clarey responded as this point to Paul A and thanked the sailing club for sending out the email and				
	letting members know of club expectations.				
	However Trevor felt that this year the Noosa Parks Assoc is trying to get a Conservation Park again. Back				
	door job in his opinion. He is worried about the Noosa River System being controlled and that he feels it will				
	contribute to becoming a World Heritage Site. This affects every user of the river he stated. It will even				
	affect the Sailing Club with boat types on the water and how they are run. He feels that the lower Noosa				
	River has needed tweaking and MSQ has been doing a good job. Trevor is concerned that by changing the				
	status of the river that unacceptable conditions will be put on the users of the river. Council have been

	discussing. Paul answered Trevor and mentioned it will be considered and looked at by the sailing club			
	committee and will keep this in mind.			
	John O mentioned that rules on combustion engines are very unlikely to be brought in and Conservation			
	Parks are over water as well as land and that the State Gov will control these designated areas should they			
	eventuate. Marine Parks are run entirely by the State Gov. Local council do not always have full control with			
	that type of listing. John O mentioned an example of marine parks and percentages of places elsewhere, that			
	have local and tourist industry. He mentioned that our group can still have a place and need to stay being involved.			
	Dave H responded that he felt the media and writings from last year was political			
	"bullshit" and he felt what was said in the media, was scaring people into thinking there was going to be no			
	boats and lots of changes. Trevor C gave an example of the Noosa River Plan not going through and if it had,			
	then the council would have had more influence and this plan was put together by community consultation.			
	President halted conversation on this.			
	Dave H then gave appreciation thanks to Paul and Sailing Club for making the sailing club hall available to our			
	small community as we don't have a community hall.			
	Paul A responded that the Sailing Club recognised that the community does have some stress from SC events			
	and some disruption at times but they are discussing with council and the club knows it is in their best			
	interest, to help the community they are in.			
	Ada M thanked Paul as well and mentioned there were "Jet skis" helping people sail. Was he aware of that?			
	Ron Thomson added that he lived near a similar lake situation and that he was disappointed that Council			
	does have a heavy hand in changing use of the Lake.			
	His example was that when first came here, he could water ski and take his family out skiing. But not			
	allowed now. Rob stopped discussion on this topic and asked that it be put on agenda for another meeting			
	time.			
	John reminded that if legistation needed changing or rules, that our group can help direct members to the right level of Government or Council or person etc.			
	Paul A mentioned, back on the topic, about the original email of Olympic interest, that it needs to be looked			
	at and the club will do it's best to involve community if they feel community is affected. Paul finished by			
	mentioning a Sir Winston S Churchill, 1947 quote that "No one pretends that democracy is perfect or all-			
	wise. Indeed it has been said that democracy is the worst form of Government except for all those other

How was the Cootharaba/ Boreen Point - Noosa Council Disaster Resilience Event 22 November 2024 Karen E mentioned she had a thankyou from council representative who had finance for running the event. The Council was happy that the event took place and hoped it gave another opportunity for new residents to find out information. Eg of the bag, booklets and USB given to those who visited the sailing club on 22 nd Nov was shown by Karen. She briefly outlined what was in the display. Warren K was happy but would have liked to have seen more new people to town, come and talk with him at the truck downstairs. Some families did come along. Ada mentioned about buying a solar torch from a lady who recommended it at the event. After use she felt that it takes a long time to charge and how much sun would be around in disaster time? Eg stormy days. Warren supported this comment and mentioned we don't have sun in all disasters. Battery or wind up torches are good and have disaster packs ready at home. The Council representatives and helpers gave out emergency packs which are to help locals keep information and important documents or copies of information together. They had the emergency services turn up such as Rural Fire Brigade, SES and other staff that locals could talk to. Some younger families did come along and they catered for the young with games and colour in activities. There were posters and information to read in the hall. There was some food provided and some families did snack while there. The organisers were happy with the event and although numbers were not huge, the word had spread about the event.		
10.	LCSC and the 2023 Olympics; General comment following PA feedback at the beginning of the meeting – nothing was added		
11.	 Illegal camping There were a few comments from the members but there's not a unanimous perspective from CCA. What are NC rules? Signage for no camping in place. Noise is dealt with through Police should it be excessive and all hours. Residents can contact authorities themselves. What are the issues? Redefined homelessness - if you have a pet you are not homeless apparently. There are groups who can be contacted for homelessness. There are rules in place for camping and signage in place by council. 		

	Most members okay with short visit if areas kept clean and tidy but definite long term stays, need to access campgrounds for facilities and toileting. Fines don't work – those camping cheaply, don't always have \$8000 in fines. Not an issue for Rosie E . Most people are happy if no rubbish is left around.
12.	Mobile Signals and Internet communications. Warren K felt it still a problem. He needs it for his emergency service and Dave Hanby also needs this for business use. He said about the problem, that it showed on a Telstra website, it has been resolved. 4G available. This is an issue across whole shire. Comments from members on the topic were heard Eg 3G has been turned off. iPhone 12 is needed. 4G is overloaded. Boosters are not the answer. They may impact on others around you. Paramedics raise issue as blackspots are not good for emergency phones. The Noosa Local Disaster groups are worried that phones are not the whole answer. It was suggested that each person should send messages to telecommunications agencies to improve but to do it individually about your area. Downgraded facilities should be mentioned in your message. Telecommunications Industry Ombudsman can be contacted if you have continuing issues with signals or not happy with the service. Dave H discussed further that it hasn't been fixed as they say. When lots of people are using it, it can be less than satisfactory. School holiday times when lots of students are home is a problem. David W mentioned that the sailing club compeititors need online information and emergency information for regattas. SES is part of police now and Warren was asked to send a letter example and suggested content that we can use as a group and support the move for better mobile and Wifi communication, to help ourselves and our disaster teams. We will try to get this for the next meeting.
	Warren K - was using his phone to bring up a weather and a rain, storm event heading our way and that we should be prepared. Cyclone may cause power outs, so remember to fix storage of water and pumps, and roofing. Internet and phone reception may go down. Have plans and what do you do? Think of your community neighbours and know who lives near you, and in our shire there are lots of new people to our communities. Karen E Clean up This is on 2 nd March and will be held at the Apollonian as usual. Not much is needed in our area but let council know or illegal dump sites or bring along batteries or plastic lids and pens to Clean Up Day. At 7.30 at the Hotel.
